Release of Liability Waiver

Please read carefully before signing!

In consideration of Watermelon Park Farm Inc. and the Camp Store furnishing services and/or equipment to enable me to participate in; (circle one)

Inner-tube Canoe Kayak. I agree as follows: I fully understand and acknowledge that outdoor recreational activities have;

(A) inherent risk, dangers and hazards and such exists in my use of Watermelon Park Farm Inc. and the Camp Store equipment and my participation in Watermelon Park Farm Inc. and the Camp Store activities; (B) My participation in such activities and/or use of such equipment may result in injury or illness including but not limited to, bodily injury, disease, drowning, strains, fractures, lacerations, partial or total paralysis, dismemberment, death or other ailments that could cause serious disability; (C) These risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Watermelon Park Farm Inc., and the Camp Store; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river route location and water level, risks of falling out of tube, canoe or kayak or drowning. I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Watermelon Park Farm Inc. and the Camp Store and it's owners, employees, officers and agents from any and all claims and actions for bodily injury, property damage, wrongful death and dismemberment, loss of services or otherwise which may arise out of my use of Watermelon Park Farm Inc. and the Camp Store equipment and/or my participation in Watermelon Park Farm Inc. and the Camp Store activities.

I specifically understand that I am releasing, discharging, and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, employees, officers or agents of Watermelon Park Farm Inc. and the Camp Store
